

The Technical Certificate (T.C.) in Emergency Administrator and Manager prepares students for employment in the field of emergency

Students will gain knowledge of all basic tenets in emergency management that are encompassed in phases of mitigation, preparedness, response, and recovery. Along with interactive experience, the student develops knowledge of community planning and coordinator and management functions. Program participants will gain an understanding of problems facing response teams, learn to write emergency plans according to government guidelines, and build communications skills as crisis advisors.

This academic roadmap does not include **developmental education courses** in reading, writing, and/or mathematics that you may be required to take. Students who place into developmental education courses are required to complete designated developmental education courses with a grade of C or higher regardless of program of study. In addition, it does not include **MAT 1033: Intermediate Algebra**, which, for many students, is a prerequisite course for MAC 1105.
