  - Accommodations for those not able to attend the posted audition dates will be considered and arranged on a case-by-case basis.
- Callbacks, if needed, will be held on Saturday, April 27 time is TBD. Callbacks are by invitation only.

### If cast:

- There will be a **Mandatory Parent Meeting on Tuesday, May 14, 2024 at 7 p.m.**
- **May 20 - 23:** Rehearsals will be Monday - Thursday from 6 - 8 p.m. unless otherwise noted
- **May 28 - June 20** Rehearsals will be Monday - Thursday from 6-9:30 p.m. unless otherwise noted
  - No rehearsal on Monday, May 27.
- **June 24 - 27 - :** Rehearsals will be Monday - Friday from 6-9:30 p.m. unless otherwise noted
- **July 3 - 18:** Rehearsals will be Monday - Friday from 6 -10 p.m. unless otherwise noted
  - As we get closer to the show, rehearsals may require extra time. We will try our best to give you at least 24 hour notice of any changes to the rehearsal schedule.
